COUNT 1

On or about February 5, 2011, in the County of Tulare, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a FELONY, was committed by **JOSE MANUEL MARTINEZ**, who did unlawfully, and with malice aforethought murder GONZALO URQUIETA, a human being.

“NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c)(1)”.

It is further alleged that the aforesaid attempted murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code section 664(a) and is a serious felony pursuant to Penal Code section 1192.7(c).
