### **Protecting and Connecting With Our Mountain Communities**



On August 29 the Pier Fire started off Highway 190 along the Tule River between Springville and Camp Nelson. One of the greatest fears of our local mountain communities along Hwy 190 became a reality, with a wild fire ravaging through some of the County's highest tree mortality areas within very steep and rocky terrain. It's a recipe for disaster for the 700 plus mountain homes in the area.

I own a cabin in Sequoia Crest and I knew along with many of my neighbors that if a wild fire ever broke out in that canyon, we'd surely be toast.

The Pier Fire burned nearly 40,000 acres and remarkably we had only minimal damage including: one outdoor building, a water flume, a Southern California Edison powerhouse and some power line polls. Considering the circumstances, that is amazing!

And I give credit to the firefighters for their extraordinary achievement!

In the height of the fight we had over 1,700 personnel from near and far battling the Pier Fire. This included firefighters, emergency management workers, helicopter pilots, water tender drivers, and the list goes on and on. Because of their effort, our mountain homes and communities were saved from the Pier Fire.

I thank you for the hard work and the long hours put in to make sure everyone had a home to return to.

It's important that we work to provide essential services to the many mountain communities in Tulare County. We are limited on the types of resources we can provide as a County to these rural communities in the higher elevations, however we always try our best to meet their needs.

This is why I hold my annual community meetings in the mountains. It's a way to stay in touch and hear their issues and concerns. In doing so, we are able to bridge gaps and find areas of services the County is able to accommodate.

Not only do we discuss County services, we also provide an open forum for residents to connect with other governmental agencies in the mountain areas such as the U.S. Forest Service, California Highway Patrol, CalTrans, and the utility companies working to remove dead trees in the mountains.

I like to host these meetings once a year, one for all the communities surrounding in the Highway 190 mountain corridor and the other in the California Hot Springs area. Unfortunately, due to the Pier Fire we had to cancel the Hwy 190 meeting.

But we are gearing up to host the annual California Hot Springs meeting on October 12<sup>th</sup> at the Capineros Community Center. Many agencies will be on hand to address resident's concerns including RMA, the Fire Department, CHP, CalTrans, Cal Fire, U.S. Forest Service, SoCal Edison, and others.

I'm looking forward to our continued work in providing services to the mountain communities of Tulare County, and when the need arises, protecting them from any natural or human caused disasters.

### County Adopts 2017/18 Recommended Budget

The Tulare County Board of Supervisors approved a \$1.2 billion fiscally sustainable spending plan recommended by the County Administrative Officer Michael Spata for Fiscal Year 2017/18.

"The budget approved by the Board is one the County can be proud of," stated Board Chairman Pete Vander Poel. "We have worked to set aside funds in preparation for the future uncertainties we as a County are bound to face."

The 2017/18
Recommended Budget
reflects a 4.3% increase
over last year's adopted
budget, with a \$2 million
increase in General County
Reserves.

The proposed strategic funding allocations include:

 \$1 million for County Economic Development projects.  Provide funds of \$1.5 million for a financial software upgrade.

- Allocating \$6.6 million to Capital Projects.
- \$1 million for the Tulare County Sheriff's Property and Evidence Facility.
- \$200,000 to be used for a County-wide homelessness program.
- Funds of \$1 million for County Parks
   Development projects.
- \$694,000 for numerous water programs.

"In its broadest sense, this Recommended Budget of \$1.2 billion is balanced, fiscally sustainable, and structurally sound," stated Spata.

"In doing so, the proposed funding allocations address both strategic and operational responsibilities." The Fiscal Year 2017/18
Recommended Budget
implements the County's
Strategic Business Plan to
address strategic and
operational opportunities, and
responsibilities.

As an example, new building permit value amounted to \$197.4 million and during the past four-years over \$790 million in new permit value was conferred on the County through application of strategic management emphasizing fiscal sustainability and economic development.

The Board of Supervisors is responsible for reviewing and approving budgets for all County operating funds, internal service and enterprise funds, County Service Areas, and dependent special districts. The Board also sits as the Redevelopment Agency and is responsible for those budgets.

#### 8th Annual Red Ribbon Week Celebration

Tulare County Health & Human Services Agency and the Tulare County Office of Education are taking a stand against alcohol and drugs during Red Ribbon Week by hosting the 8th Annual Red Ribbon Week Celebration on Wednesday, October 18, from 3:00-6:00 p.m. at the Visalia Convention Center.

Students and their families are invited to attend the free event, which features live entertainment, information booths, games, family and student-oriented activities, and more.

This event is free for students and parents. It will commemorate Drug Enforcement Administration (DEA) Special Agent Enrique S. "Kiki" Camarena. He served in the military, became a police officer, then an undercover agent with the DEA investigating drug cartels in Mexico, where he was murdered.

Camarena declared, "I am only one person, but I want to

make a difference."

Red Ribbon Week promotes a healthy, drug free lifestyle and is a collaboration of community partners including the County of Tulare, The Tulare County Office of Education, the Tule River Tribe, Family Health Care Network, ProYouth, and others.
