## Supervisor's Message: County Works to Improve Efficiency



As my first year serving on the Tulare County Board of Supervisors draws to a close, I am proud of the steps our Board has taken to improve the efficiency in government. Especially during difficult economic times, it is increasingly important that we as Tulare County employees continue to improve our service to homeowners, landowners, businesses and constituents.

An example of these efforts took place earlier this week when the Board approved the Tulare County Resource Management Agency improving the process of obtaining a special use permit. There used to be a multiple step process to obtain and pay for this permit, however, a one step "cost recovery" process will now be created. Once fully implemented, this improved procedure will make it easier

for people applying for these permits by decreasing the processing time and reducing overall costs to both the County and the applicants.

On another front, Tulare County is in the process of creating a Joint Powers Authority (JPA) with Fresno County, the San Joaquin Valley Insurance Authority (SJVIA), which will provide medical and health benefit programs to County employees. Premiums paid by employees for medical prescriptions and vision benefits are likely to go down through the SJVIA.

During the years from 2006-2009, there were annual increases to premiums paid for medical coverage. Had the County not created this authority, there would have been another increase of 4.1% for each employee over the next year. However, by joining the SJVIA, it is anticipated that there will not be a premium increase on medical benefits this fiscal year.

From my perspective, another way of improving the efficiency of government is

through training and education. I was pleased to help coordinate Government 101: Special Districts, a training session for elected board members serving Districts (Community Service Districts, Water Districts, Memorial Districts, etc.) throughout the County. Topics covered included the Brown Act, Public Records Act, Proposition 218, conflicts of interest, and overall boardmanship. As a result of this session, I believe the people of Tulare County will be better served by their elected leaders and boards.

Lastly, please feel free to contact the Board with any questions or suggestions. We are all here to help. As a board, we will continue to work towards improved efficiency, customer service and improving the function of local government.

The CWS Toy Drive aims to provide at least one new gift to each child in the program, which in total averages over 1,500 participants.

"We don't want these children to feel alone or forgotten this holiday season," says Smylie. "These children are in the system because of circumstances outside of their control, and it is vitally important that we help to make them

feel valued, cared for, and loved."

grandchildren, two dogs, and three cats.


**Hobbies:** Cooking, gardening (I'm a student in the Horticulture Program at COS), golf, and photography.

## First Aid Training Pays Off for Employee

As a code compliance officer with Tulare County's Resource Management Agency, Janie Sustaita's job is to assist people. Janie went above-and-beyond her job description on October 30 when she performed basic first aid on a resident who passed out at a funeral.

While attending the Oct. 30 funeral, Janie said she witnessed a man pass out in the parking lot.

“Everyone was gawking,” Janie said. “I ran over there and tried to talk to him. His eyes rolled back and he lost consciousness.”

Janie said she directed funeral attendees to call 9-1-1 and clear the area around the man. Another funeral attendee steadied the man's head while Janie started compressions.

Janie said after the man regained consciousness, she asked him questions and directed him to move his limbs until an ambulance could arrive.

Janie credits a Tulare County-sponsored CPR class she took just the day before as the reason why she was able to assist him.

When asked about what was going through her mind when she witnessed the man faint to the ground, Janie gave this response:

“I didn't think at all. I just helped him and performed CPR because it was so fresh in my head.”

Janie took the CPR/AED class as part of a pilot project that will place AED's (Automatic Difelibrillators) in county facilities. The devices are being donated by the Visalia Breakfast Rotary.

The placement of AED's requires that two county employees in each building are CPR/AED trained as a first responder.

Janie said she volunteered to be the CPR/AED trained employee for her department.

Debbie Vaughn, a CAO analyst spearheading the AED pilot project, said she is excited that the training paid immediate dividends, but wants to urge more county employees to participate in the program.

“It gives people the opportunity to be prepared to save another person's life,” Vaughn said. “Not only at work but in public.”
