### Supervisor's Message: Leaders Lobby in Washington, D.C.



Members of the Tulare County Board of Supervisors and officials with the Tulare County Association of Governments (TCAG) will travel to Washington, D.C. from February 28 through March 4 as part of an annual "One Voice Trip."

As local leaders, each delegation will meet with Federal elected officials and policymakers in support of vital projects to Tulare County. This annual visit to Washington, D.C. has proven to be beneficial. For example, efforts at the State and Federal level last year led to Tulare County acquiring more than \$92 million in road project funding from the California **Transportation Commission** for the widening of Highway 99 between Goshen and Kingsburg.

This year, the TCAG delegation, which includes County Supervisors and representatives from multiple incorporated cities, will attend a variety of transportation-related meetings. Some of the projects and policy items up for discussion include:

- Requesting funds for additional Highway 99 widening in Tulare County.
- Continuation of the Congestion Mitigation and Air Quality Program and Bridge Program in the next transportation authorization.
- Support for short haul rail and protection against abandonments.

In addition to TCAG requests, members of the Tulare County Board of Supervisors will meet with Federal representatives to lobby for the following items:

- The need for existing funding through the USDA to allow for preliminary design and engineering for water systems for disadvantaged communities.

- Additional funding for marijuana eradication on Federal lands.
- Funding for the remediation of Success Dam.

The results of these visits often aren't immediately known. However, by looking at the outcomes of previous visits, these face-to-face meetings have proven to benefit all of Tulare County.

# Redistricting Committee Applications Available

Residents interested in participating in an advisory group to make recommendations on how to redraw Tulare County's Supervisorial district boundaries need to submit an application by March 8.

Supervisorial districts are redrawn every ten years

based on population counts collected by the United States Census. The 2010 Census data will be released April 1, 2011.

The Redistricting Advisory Committee is charged with developing criteria to be applied during the redistricting process and developing proposals to be presented to the Board of Supervisors. The Committee will also conduct outreach meetings in various parts of Tulare County to solicit public input. The Redistricting Advisory Committee will present their final report to the Board of Supervisors by August 1, 2011.

## **Employees, Public Impacted by Courthouse Closure**

The Tulare County Superior Courthouse in Visalia was closed from Feb. 2-4 to the public and County and State employees due to a power failure. Power to the courthouse was restored and employees reported back to work on Feb. 7.

Tulare County officials said a power failure at the Tulare County Main Jail and Courthouse was reported sometime after midnight on Feb. 1. Emergency generators at the main jail were activated and there was no lapse in power coverage. A maintenance call was placed to check power at the courthouse.

It was determined that the cause of the failure was a short circuit, which created a major power failure in the main electrical feed in an exterior vault outside of the courthouse. The power outage was isolated to the courthouse and main jail. Surrounding

areas were not affected.

Tulare County officials advised the public there would be no services available at the courthouse in Visalia for the rest of the week. Employees working in the courthouse were notified via AlertTC, an emergency notification system. More than 550 County employees work in the courthouse.

"We understand that this power failure created a major inconvenience for both the public and employees," said Kristin Bennett, Assistant County Administrative Officer. "To avoid public safety and workflow issues, it was important that the courthouse be vacated for the remainder of the week."

Bennett said facilities staff and electrical vendors completed full inspections, assessments and initiated repairs. Repairs included: new 5,000 volt feeder cables, conduit and connections; and a thorough cleaning of all high-voltage electrical components. Power was restored on Saturday, Feb. 5.

To mitigate the odor, facilities coordinated with outside vendors to provide complete replacement of all air filters. Activated charcoal filters, HEPA filtration units and nanometer scrubbers were operated for 48 hours.

In addition, walls, floors, and surfaces were thoroughly cleaned in the impacted areas of the ground floor and first floor.

"We wish to extend thanks to all employees for your patience and support during this incident," Bennett said. "A special thanks to the Sheriff's Department for providing 24-7 security, to Facilities for their outstanding response, IT for amazing technical support, and OES for the TCAlert notifications."

## Slick Rock Film Festival Adds Step Up Category

Slick Rock Film Festival, the San Joaquin Valley's premier student film competition, has added a "Step Up" antiviolence, anti-gang category.

Participants who enter the Step Up category have a chance to earn a high-definition flip video camera, have their entry featured on prime-time television, and conduct an interview on KMPH's Great Day morning program. Students are being asked to produce a 30-second advertisement that targets gang or violence prevention.

District Three Supervisor Phil Cox said the Board of Supervisors and the Tulare County Film Commission are partnering with the Slick Rock Film Festival in an effort to promote the Step Up anti-gang program among high-school aged youth.

"Tulare County's gang task force has done an excellent job in reaching thousands of people through educational summits and grant programs," Supervisor Cox said.
"Through the film festival, we feel we can utilize a youth-created advertising tool to reach our biggest target audience: youth."

Step Up-themed Slick Rock entries must include the Step Up logo and website address www.stepuptc.com, the "Be Part of the Solution" slogan, convey a message that violence is never the answer, and be 30 seconds in length.

Films must be submitted through the Slick Rock Film Festival portal between March 1, 2011 and April 15, 2011. An entry form must be completed and submitted by the advisor between March 1, 2011 and April 15, 2011.

The Slick Rock Film Festival concludes at the Award Ceremony on Saturday, May 14 at Fox Theater in downtown Visalia.

# **Program Spotlight: CSET's VITA Program**

Community Services & Employment Training, Inc. (CSET) is gearing up for its 6th year of providing free income tax preparation services to lower-income families through the Volunteer Income Tax Assistance (VITA) Program.

CSET will provide these valuable services to households with annual incomes below \$50,000. The VITA Program allows taxpayers to electronically file (e-file) tax returns, which enables them to receive their refund within 5 to 10 business days.

Tax time will provide some much needed financial relief to many struggling families. Help your friends, family, colleagues, employees, and clients keep more of their income tax refund by sharing information about the program.

The free program will began February 3 and operates through April 16, 2011 at VITA sites in Visalia, Tulare, Porterville, and Orosi. Last year, CSET and many local volunteers provided assistance to more than 1,500 low-income taxpayers and brought back almost \$2.8 million in federal refunds to the local economy through the VITA Program.
