More than 900 Tulare County students representing 36 high schools attended the March 11 Step Up Youth Summit at the McDermont Field House in the City of Lindsay.

The summit's goal was to educate and inform students about opportunities available to them and provide information on positive decision-making through a series of high-powered workshops.

As the Step Up Youth Summit Planning Committee Chairman, I am proud to report the efforts of this youth-focused event will last far beyond one day.

A follow up committee has

been formed to visit with student attendees during the next few months.

Currently, summit attendees are participating in an online survey regarding the event. The follow up committee will visit these students face-to-face to measure success and determine the pros and cons of the event.

While the Step Up Youth Summit targets high schoolaged students, members of the Tulare County Gang Prevention Task Force - the group responsible for planning Step Up events - thought it would be a great idea to target youth in elementary and middle schools. The Board of Supervisors agree whole heartedly and will continue to support those efforts.

Members of the Tulare County Gang Prevention Task Force are working to create and begin to implement a campaign that reaches our younger students. Initial ideas revolve around more youth-focused events and on-going programs such as the Step Up Service Learning Grant Program.

Two Tulare Gang Awareness Forums Slated for April

City of Tulare, Tulare County, Tulare Police Department, and Tulare school officials will partner to host two gang awareness forums in April.

The purpose of the Tulare Gang Awareness Forums, scheduled for April 15 and 22, is to educate the public on gang prevention and suppression strategies, community safety, and how residents can get involved in combating gang activity, said District Two Supervisor Pete Vander Poel, who represents Tulare.

"The problems caused by gangs and gang activities are difficult to address with only one agency," Supervisor Vander Poel said. "That's why it's important to take a multi-faceted approach to gang prevention. It's great to work with such a diverse group of partners to help increase gang awareness in the city of Tulare."

The first forum is scheduled from 5:30 p.m. to 8 p.m. on Thursday, April 15 at Mulcahy Middle School in Tulare. The second forum is scheduled from 5:30 p.m. to 8 p.m. on Thursday, April 22 at Mission Oak High School in Tulare.

Both forums will feature a one-hour resource fair, a guest presentation, and a panel of guest speakers to address gang issues and answer questions from the public. The panel includes: Supervisor Pete Vander Poel; Tulare Mayor Craig Vejvoda;

Sheriff Bill Wittman; Tulare Police Chief Jerry Breckinridge; District Attorney Phil Cline; and Probation Chief Janet Honadle. Tulare Police Chief Breckinridge said the partnership between the city, county, law enforcement, and schools is a promising sign of cooperation among agencies to combat gangs and their influences.

"We have done well working with our youth, trying to prevent them from being influenced by gangs," Chief Breckinridge said. "Through community involvement and the efforts of the police department, we reach a large number of children on a daily basis. We now need to address a very vital component of intervention and prevention - the parents. Unfortunately, a lot of parents do not know what to look for when it comes to their children being involved with gangs... until it is too late. This forum truly represents the collaborative effort each agency is putting forth to address the quality of life in our community."

Tulare County Sheriff Bill Wittman said collaboration among agencies improves intervention and prevention steps towards the suppression of gang violence. A multifaceted and coordinated approach combines suppression, prevention, and intervention, which are necessary components in developing long-term and short term strategies and

programs to address gang violence. Law enforcement agencies combined with faith and community-based organizations, education, government, and private businesses all play critical roles in gang reduction and intervention efforts.

"Agencies and communities working together to address gang issues is a must for a safer community," Sheriff Wittman said.

Supervisor Vander Poel said the gang awareness forums are part of a series of anti-gang events he will continue to bring to the residents of District Two, which includes Allensworth, Alpaugh, Earlimart, Pixley, Teviston, Tipton, Richgrove, Woodville and Waukena.

The Tulare Gang Awareness Forum is a partnership between the Tulare County Board of Supervisors, City of Tulare, Tulare Police Department, Tulare County Sheriff's Department, Tulare County District Attorney's Office, Tulare County Probation Department, Tulare City Elementary School District, and the Tulare Joint Union High School District.

The Tulare County Sheriff's Posse formed in 1940. In the vast agricultural area, many of the local farmers and ranchers were routinely called to assist the Sheriff's Department, and that tradition continues with local volunteers. Currently, the Posse has a large mounted unit, founded in 1995, that responds to search and rescue call-outs with horses.
